SYSTEM DESCRIPTION

The FX-12E empty water filtration system for foodservice applications allows the flexibility to choose the appropriate filter cartridge to fit your needs. The system includes the mounting bracket, mounting hardware, pressure gauge, inlet shut-off valve, and sump.

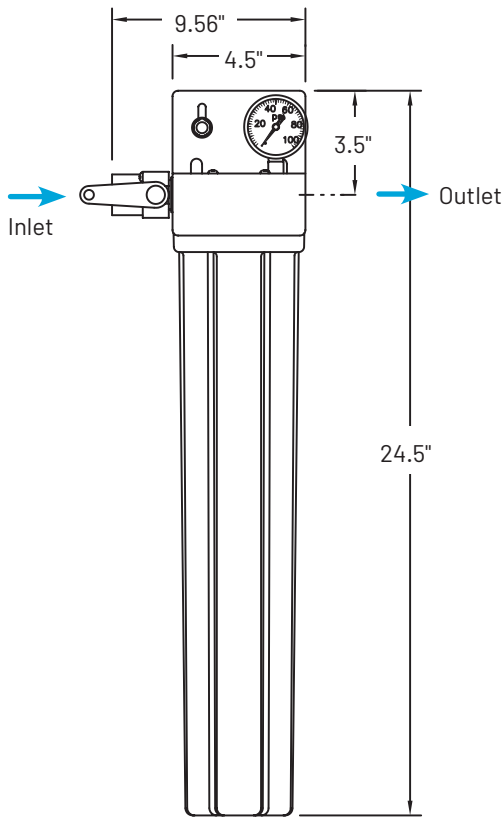
- ◆ Sturdy mounting bracket and full-flow inlet shut-off valve simplify installation
- ◆ Built-in pressure gauge allows visual monitoring when filters need to be changed
- ◆ Inlet shut-off and depressurization valves make filter replacement quick and simple
- ◆ Minimizes waste by only replacing drop-in cartridge and reusing filter sump

INSTALLATION TIPS

- ◆ Choose a mounting location suitable to support the weight of the system while operating.
- ◆ Install vertically and allow 2½" (6.35 cm) clearance below the sump for easy removal and replacement.
- ◆ Feed water temperature must not exceed 100°F (38°C).
- ◆ Do not install where the system could be exposed to freezing temperatures.
- ◆ Feed water supply pressure must not exceed 125 psi (non-shock). When pressure exceeds 85 psi, a pressure reducing valve is recommended.
- ◆ Detailed installation, operation and maintenance manual included with the system.
