- ◆ Allow 3" clearance below system for filter housing removal and cartridge replacement.

### OPERATION TIPS

- ◆ Change cartridges on a regular six (6) month preventative maintenance program.
- ◆ Change cartridges when capacity is reached or when flow becomes too slow.
- ◆ Always flush the filter cartridge at time of installation and cartridge change.

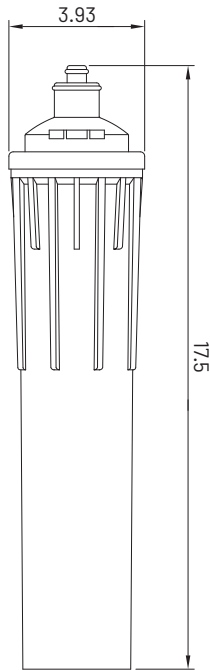
